# VOTING MEMBERSHIP

Voting members of the Association are individuals, partnerships, or legal entities that own or operate continuing care facilities or services in Alberta. These include home care, designated supportive living, and long term care.

Voting members enjoy full membership privileges, including:

-  The right to vote at meetings
-  Hold positions on the ACCA Board of Directors
-  Government liaison and advocacy
-  Opportunities to participate in Government and ACCA interest groups and committees
-  Regular newsletters and sector updates
-  Discounted rates on continuing care service costs

## Voting Membership Fees



### HOME CARE MEMBER

\$2,000/year minimum to \$18,000/year maximum based on total annual hours (+GST)

*Example: 100,000 hours = \$2,000/year (+GST)*

---



### DESIGNATED SUPPORTIVE LIVING MEMBER

*Total Spaces / Beds*

1-50 spaces: \$2,050/year (+GST)

+71 spaces: \$42.85/space, up to \$30,000/year maximum (+GST)

---



### LONG TERM CARE MEMBER

*Total Spaces / Beds*

1-50 spaces: \$2,050/year (+GST)

51-70 spaces: \$4,500/year (+GST)

+106 spaces: \$42.85/space, up to \$45,000/year maximum (+GST)

# BUSINESS PARTNER MEMBERSHIP

Business Partner members are individuals, firms, or legal entities with an interest in the activities of the Association or its members. This includes organizations or individuals that may provide products and services to the Association and/or continuing care operators, as well as those that support ACCA's mission but do not directly provide continuing care services. While Business Partner members do not have the right to vote at meetings or hold positions on the ACCA Board, they are invited to attend ACCA meetings. Examples of Business Partner members include providers of healthcare and support services, medical supplies, nutrition and food services, building construction, pharmacies, insurance and financial services, educational institutions, and other associations.
