RE: Emergency & Disaster Management Policy

I am writing to inform you of an important update regarding the Emergency Response Codes Policy (as referenced in the AHS Policies Schedule (Schedule B) of the Agreement). As part of our ongoing efforts to improve emergency preparedness across the healthcare system and streamline information, AHS has amalgamated content from the Emergency Response Codes Policy with the Emergency Disaster Management Policy.

Effective February 13, 2025, all continuing care contracted service providers (CSPs) will be required to adopt and align with the AHS Emergency Disaster Management Policy (policy) which went into effect February 10, 2025. The AHS Emergency Response Codes Policy will be available for reference until February 13, 2025.

Revisions were made to the policy to align with federal policy on Emergency Management and other legislation, such as the Public Health Act, Emergency Management Act, Occupational Health and Safety Act, and the National Fire Code (2023 Alberta Edition). Alignment with the AHS policy supports CSPs to meet their legislative requirements. The revised policy emphasizes the critical importance of collaboration and proactive planning to ensure the safety and well-being of all individuals within our care facilities.

In response to this policy change:

- Review and implement the AHS Emergency Disaster Management policy.
- Familiarize your leadership teams and staff with the resources and education available on the Continuing Care Connection website.
- Review any operational/organizational resources and education for alignment with the policy.
- Rescind/remove all references and links to the AHS Emergency Response Codes Policy.



# **Key Messages for Operators and Staff:**

## Collaboration is Key to Success

Successful emergency disaster management occurs when there is seamless
collaboration between stakeholders. This means a unified approach between
contracted continuing care operators, AHS (Alberta Health Services)
personnel, and other partners in responding to emergencies. Together, we
must ensure that we are ready for any emergency situation, with clear
communication, clear roles and responsibilities, and coordinated efforts.

### **Our Commitment to Preparedness**

The E/DM Division within AHS remains dedicated to preparing the
organization, its facilities, and our contracted partners to effectively respond
to and recover from any major emergency or disaster. This preparation
includes ongoing training, resource sharing, and the development of policies
that ensure we are ready to act swiftly when needed. Resources have been
added to the Continuing Care Connection website to support planning and
education.

### Operator Responsibility

While the E/DM Division provides guidance and support, the ultimate
responsibility for the development, implementation, and evaluation of
emergency response plans continues to fall on each contracted operator and
their respective organizations. Each operator is required to ensure that
emergency plans are in place, staff are trained, and procedures are regularly
reviewed and updated.

We ask that you review your current emergency disaster management plans considering this updated policy and ensure that they align.
